TERMS AND CONDITIONS

TERMS OF SALE

1. Standard terms of sale are Net 30 days from date of invoice. Any account that is not paid within the terms is considered "PAST DUE".
2. In the event of "PAST DUE" balances, at the option of Bradco Imports, no further orders will be released.
3. The Customer agrees to pay interest at the rate of 19.56% per annum (1.5% per month), and will be charged at the option of Bradco Imports on "PAST DUE" invoices set out in #1.
4. If cost are incurred in collection of overdue account, the Customer will, on written demand, pay for all legal and/or collection cost incurred by Bradco Imports. Any check returned from the bank will be subject to a \$ 20.00 administration fee.
5. All orders accepted prior to credit approval will be sent out after Bradco Imports has received the payment.
6. Recurrences of a Customer having shipments withheld due to "PAST DUE" balances may cause, at the option of Bradco Imports, orders not being accepted or the account being closed.
7. The credit approval for a Customer ceases upon a change of ownership or structure of the Customer (i.e. Proprietor or partnership to a corporation).
8. The Customer authorizes Bradco Imports to obtain all credit information Bradco Imports considers necessary in connection with this application.

11. If you do not agree with any of the contents of a particular invoice, you must advise the Bradco Imports Invoicing Department in writing, within 15 days receipt of the invoice(s), accurately indicate the amount owing Bradco Imports.
12. The customer agrees with acceptance of a consignment order by the customer (consignee), Bradco Imports (consignor), retains full title of the complete consignment order. Consignee agrees that consignor is allowed access to the complete consignment merchandise in order to take possession of the consignment.
13. Bradco Imports reserves the right to alter payment terms and credit limits if terms and conditions are not followed.
